

**TEAM Act Would Re-Focus Funds to Support School Transitions and Integrated Employment**

Earlier this month the TEAM Act legislation was re-introduced. There are three bills referred to as the "Transition toward Excellence, Achievement and Mobility Act (TEAM Act). This legislative package will focus on helping people with disabilities gain full-time employment in an integrated environment at a livable wage. **Achieving a Better Life Experience**

The Achieving a Better Life Experience or ABLE Act was re-introduced in both the House and Senate earlier this month. It would give people with disabilities access to savings accounts, allowing them choice and control, while protecting their Medicaid, SSI and other benefits. Savings accounts could be created accruing interest tax-free. The account could also fund a variety of essential expenses including medical and dental care, education, community based supports, employment training, assistive technology, housing and transportation. Upon introduction of the legislation, 59 original House and 16 original Senate co-sponsors have already signed on. **Regions Announced for Michigan's Integrated Care Proposal**

Wayne and Macomb Counties have been chosen as two of the four regions to be involved in a pilot project to strengthen services and supports for people who are dually eligible for Medicare and Medicaid. This pilot will be implemented by the Michigan Department of Community Health in conjunction with The Centers for Medicare and Medicaid.

This integrated care project is designed to improve access, quality and outcomes by more effectively aligning Medicare and Medicaid services and bridging the gap between physical health, long term care and behavioral health systems.

"MDCH's integrated project will support the work CLS has been doing over the last few years to align and integrate the services and supports it offers across systems for people with disabilities, older adults, veterans and the underserved, many of whom are dually eligible. We believe this will make it easier for people to navigate the system," said CEO/President of CLS Jim Dehem. "The new system, though, will not interrupt the way services are delivered to people supported by CLS. Integration will offer people more options to choose from but coverage will not lapse in any way. There will also be the choice to 'opt out' of the plan if people choose to do that as well," said Dehem.

The other two regions chosen are: the Upper Peninsula and a region in the southwest part of the state which includes Barry, Berrien, Branch, Calhoun, Cass, Kalamazoo, St. Joseph and Van Buren counties. The goal is to begin implementation in January 2014 with outreach, education and enrollment starting in October 2013.

"I am glad to be a part of a group that is working on the statewide model for dual eligibility for Michigan," said Janey Vermeulen. Janey, who is currently training with CLS to become a Peer Mentor, has been invited to be a member of the Eligibility and Enrollment Work Group for the Integrated Care Demonstration Project. She is on the Outreach and Education committee. Part of her role is to give advice on how to educate the public once the project is finalized.

# Long Term Care

## Long Term Care Services for Livonia Family

Vera Plumaj is a busy woman. She runs her own business with her husband, is a Realtor and has three children. So when the question of who will take care of her mother-in-law was raised, she wasn't sure what to do. "My husband's mother has dementia and was being cared for by family, but when it became too much, a decision was made to place her in a nursing home. When I saw her in

there I knew we had to get her out and within three days, we brought her home to our house," said Vera.

After her 78-year-old mother-in-law came to live with her, Vera wasn't sure where to turn for help. They faced many difficulties with access and eligibility for Medicaid, primarily because the system was so difficult to navigate. It took help from the CLS Long Term Care division to secure temporary support through its United Way grant and then helped the family navigate the Medicaid eligibility system and secure MI Choice Waiver services. "I talked with Katie Olver and she set things in motion right away. There was a lot of paperwork and many obstacles but eventually we got approved for Medicaid and the waiver services and it has been working out very well," said Vera.

The MI Choice Waiver funds home and community based supports. This Waiver is for eligible adults who qualify for Medicaid and require consistent care so they can avoid going to a nursing home. Eligibility for Medicaid is approved through The Department of Human Services. Once the approval process begins, those who also meet the MI Choice Waiver requirements can begin working with a Waiver Agency to be approved for services within their home.

"I think my mother-in-law has adjusted very well and I am grateful to CLS for all of their help," said Vera.

The Senior Alliance AAA 1-C is reporting calls are being placed to seniors throughout the nation from someone claiming to be a Medicare service rep. **This is a scam!** Medicare will **never** call a beneficiary!

The caller identifies themselves as a service representative from Medicare calling from Washington or Pennsylvania. Seniors are being told Medicare has a new "Preferred Medicare Card" that is to be used with the original Medicare card. The caller is requesting bank routing and account numbers to be used for this new card. Some seniors have been promised gifts. The caller claims this new Preferred Medicare Card is part of the ACA changes or OBAMA Care. Please let anyone you know not to give out their information!
